

COVID-19 IMPACT – SHANGHAI, MAY 17TH

<ul style="list-style-type: none"> As of 10:00AM May 17th, Shanghai reported 57,260 positive cases (77 new cases) , 585, 725 asymptomatic cases (746 new cases) totally since Mar 1st Up to date, all 16 districts in the city have achieved social clearance. Starting from 12am of Apr 2nd, people leaving Shanghai should show their negative antigen test result within 24 hours along with a negative report of nucleic acid test within 48 hours. Shanghai city will continue to carry out “nucleic acid + antigen” combination method to take the screening work and adjust “3 Risk Areas” dynamically according to the screening results. Shanghai official announced the next step of prevention and control, which is divided into “three stages”: 1st Stage: From now – May 21st, orderly opening “Precautionary areas” to keep lower level of social activity. 2nd Stage: May 22nd – May 31st, continue to narrow the scope of “Controlled areas” & “Locked-down areas” until lift. And speed up changing to normalized prevention and control and classification management. 3rd Stage: Jun 1st – Mid to late Jun, fully restore to normal production and life with normalized prevention and control management. 	<ul style="list-style-type: none"> Our People remain all safe, majority are working from home to support daily work. 上海

- 自3/1以来, 截止至5/17 10:00, 上海共报告57,260例确诊病例 (新增77例)
- 自3/1以来, 截止至5/17 10:00, 上海共报告585,725例无症状病例 (新增746例)
- 目前, 全市16个区都已实现社会面清零。
- 4月2日零时起, 离沪人员除需持有48小时内核酸检测阴性证明外, 还须提供24小时内抗原检测阴性证明
- 上海将继续采用“核酸+抗原”组合方式, 分区开展筛查工作, 并根据检测结果, 动态调整三区范围
- 政府已明确了下一步防控工作, 分为“三个阶段”
- 第一阶段: 从现在开始到5月21日, 有序开放防控区, 全市保持低水平社会活动。
- 第二阶段: 5月22日至5月31日, 不断缩小封控区和管控区范围直至解封, 加快向常态化分级分类管理转变。
- 第三阶段: 6月1日至6月中旬, 疫情防控常态化管理下全面恢复全市正常生产生活秩序。

海运出口

- 仓库持续闭环管理, 仅留少数人维持有限操作, 恢复日期待定
- 我们持续寻求整柜及拼箱操作的替代方案, 例如宁波等就近港口. 操作团队会和海外以及客户即时沟通 拟定出运计划
- 部分船公司提供陆转铁和陆转水服务, 根据客户情况和要求提供具体方案

海运进口

- 整柜无纸化线上换单以各家船公司可操作为准
- 部分拼箱分拨仓换单业务恢复 - 分拨仓提柜/分拨/理货作业有限恢复
- 市内整柜集装箱卡车提货需要提供海关放行单/港区EIR提货单/24小时核酸报告 or 48小时核酸报告 + 24小时抗原检测
- 冷藏集装箱插座供应恢复正常
- 危险品柜堆存空间得到了极大的缓解
- 提箱计划 04/22 - 05/20期间, 可减免50%堆存费
- 各家航司推出不同减免政策 (用箱, 改港, 改单, 电放等)
- 上海海运进口改港/转港/中转需求, 需一票一议提供相对应方案。

空运出口

- 空运出口仓库和地面代理目前维持正常运作, 作业效率将受限制
- 已开发周边备选机场方案提供服务, 例如郑州, 武汉, 重庆, 成都等, 目前郑州航空港不接受曾经由上海及吉林行驶轨迹卡车
- 浦东机场取消约30%运力。

空运进口

- 空运进口仓库和地面代理目前维持正常运作, 作业效率将受限制
- 货站温控/危险品仓库库容压力适度缓解, 对新货物实行逐票确认, 提前预约的操作方式
- 进口提货司机需要提供48小时内核酸阴性报告和24小时内抗原阴性
- 郑州机场暂停接收空运进口货物中转至上海
- 郑州5/11封控解除, 航司恢复郑州卡班中转到上海浦东机场

关务

- 进出口报关目前维持正常运作
- 海关查验和现场单证处理将受影响
- PVG海关开设在线平台执行‘无陪同查验’
- 浦江海关, 洋山海关, 浦东机场海关公布滞报金减免通知, 针对包括3月11日及后运抵的货物, 以上海市政府公布的复工时间为节点。

仓储

- 根据上海政府的最新疫情防控要求DS 所有仓库现在是关闭状态, 停止操作, 从3月28日起关闭, 恢复日期待定, 以政府最终公告为准。
- 临时仓库, 需要一事一议提供相对应方案

国内运输

- 长途干线运输 长途零担干线基本停发。目前有部分零星线路可以一票一议, 发车班次和时效不固定
- 上海市内运输 需运输许可证, 一票一议
- 国内铁路 行邮集拼线路继续停发。个别点通过包车皮方式或者集装箱慢速列车可以单票单询
- 国内空运 上海仓库操作封闭 客机航班在两大机场基本全部取消
- 自4月2日起上海高速道口 进出沪方向实施交通管制, 进出沪车辆所载驾人员需持运输许可证, 48小时内核酸检测阴性证明外, 还须提供24小时内抗原检测阴性证明, 目前卡车市场资源有限
- 自4月1日起, 所有往返或者途径俄罗斯的铁路业务 (包括中欧铁路) 将暂停等待进一步合规评估及通知
